Dear Parents/Carers

I wanted to remind you all parents, in receipt of certain benefits, might be entitled to Free School Meals based on a low income. Even if your child only has the occasional school meal, I would urge you to apply if you think you may be entitled.

I have attached a copy of the Free School Meal application with this letter, which provides more information; you can also apply online using the link below https://fiso.norfolk.gov.uk/synergy/neo/Enquiries/Citizen/FreeSchoolMeals.aspx If your circumstances change this link is always on the Newsletters sent home, and past issues are available on our website.

I also wanted to remind all parents that any lunch money owing should be paid in full at the end of each week; you can also add a credit to your child's meal account ready for the following week. We do have a strict Trust policy for school meal payments and the procedures that we need to follow if monies are owed, I have detailed this below for your information.

Parents who owe one week's dinner money will be contacted by the school at the end of the week and asked to pay the outstanding debt by the following week.

Parents who owe two weeks' dinner money will be contacted by the school at the end of the second week and informed that their child will need to bring packed lunches from the start of the following week unless the parent makes an arrangement with the school to repay the debt.

FREE SCHOOL MEALS AND PUPIL PREMIUM APPLICATION

Dear Parent/Guardian,

We want to make sure that we are providing your child with the best education and support we can. Healthy school food has obvious health benefits and can help pupils establish healthy habits for life. Healthy school food can also help to improve pupils' readiness to learn.

Families who receive certain benefits may be eligible for free school meals. Your child is eligible for free school meals if you're in receipt of one of the following benefits:

- Universal Credit with an annual net earned income of no more than £7,400.
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part 6 of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit

 Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)

 Child Tax Credit (with no Working Tax Credit) with an annual income of no more than £16,190

Registering for free meals could also raise an extra (£1,320 for your child's primary school)/(£900 for your child's secondary school), to fund valuable support like extra tuition, additional teaching staff or after school activities.

This additional money is available from central government for every child whose parent is receiving one of the benefits listed above.


