Questions and Comments Raised by Governors

First Aid Policies

I support the proposed First Aid policy for HJS; I note that the policy for HINS is to come -RD I think an action needs to be allocated to a first aider per school, to check that first aid kits are complete and replenished - KW.

KW happy to sort this out for HJS on an ongoing basis if helpful.

Do we display first aider names around schools and have lists been updated since training was received in March? – KW

Happy to take on responsibility for this at HJS if needed - KW.

Head teacher's Report - Heacham

I have some comments about the table describing persistent absence – which is potentially misleading as I do not believe SEND children at HINS have a persistent absence rate of 88% - this is what appears in the table: 88.03%. The heading also applies to the HJS attendance data.

School on a Page (SOAP)

The school on a page reports are helpful. Attendance has been disappointing but is not going to be an issue now this year. -RD

Progress and outcome data are going to be difficult to analyse. We need to keep watching for and trying to minimise gaps between different cohorts of children- RD I'm not sure what all of the acronyms stand for within the 'school on a page' document, so might have to ask you about these at our next meeting - KW

SEFs (Self Evaluation Forms)

I have read and support the draft SEFs for both Heacham schools. I am not quite sure what the highlighted sections mean in the HJS document. – RD

Sedgeford Consultation

It is very sad to read the consultation about Sedgeford, but inevitable, I fear - RD

Website Audit Heacham Junior School

Website audit carried out on HJS and shared with Head teacher.

Website audit identifies no whistle blower policy on the website, but this is on the Trust website policies section – AGN

Have website amendments recommended by the website audit been delegated out to staff to complete? – KW
